

Professional Licensure Disclosure Statements

In accordance with federal requirements and as a member of the State Authorization Reciprocity Agreement participating institution, Trinity Bible College and Graduate School provides public and direct Professional Licensure Disclosure Statements as set forth in this policy. Academic program leaders who operate units that offer education programs that may be reasonably assumed to lead to professional licensure, certification, or endorsement are responsible for determining whether its curriculum meets the state educational requirements for professional licensure or certification in states where their students are located and for maintaining the accuracy of this information as listed in the Professional Licensure by State Table, which the College is required to publish as part of its disclosure of student consumer information.

Students Responsibility - Students should review the specific academic requirements for the program in which they are enrolling, including those related to practicum/internship as well as pre-qualifications for licensure such as the need for a criminal background check. We highly recommend that students contact the applicable licensure board(s) in their state of residence or in the state where they intend to obtain a license before beginning an academic program that results in licensure and prior to beginning any internship/practicum. Many licensure boards have additional requirements beyond successful degree completion to obtain a license. Please be advised that state laws, regulations, and policies may change at any time. Changes in requirements can impact the program's ability to meet educational requirements for licensure. It is the responsibility of the student completing the licensure program to check with the licensing board(s) in their state of residence or in the state in which they intend to obtain a license for the most recent information and requirements. Trinity Bible College & Graduate School shall not be held liable if the student is unable to qualify for licensure or certification in any jurisdiction or cannot obtain a practicum/internship location.
